He reported on discussions about the defibrillator with Cllrs Andrews and Bailey and it was now suggested it be installed on the Recreation Hall close to the Doctors' surgery. This would be agreeable to the Recreation Hall Committee and was agreed.

421 **b** **Memorial Hall**

Cllr Collins reported that no meeting had been held. He said that the shed had to be cleared out, in order to return it to the Memorial Hall Committee at the end of the month. It was agreed a working party be formed of Cllrs Crozer, Collins and Williams to see if it would be possible to move the contents to the street cleaners' garage and to deal with the matter.
