1 APOLOGIES FOR ABSENCE

417 All parish councillors present. An apology for absence due to illness was received from Mrs Roxana Brammer, Clerk.

2 DECLARATIONS OF INTEREST AND MEMBERS' REGISTER OF INTERESTS

418 None.

3 MINUTES OF THE MEETING HELD ON 10 JANUARY 2018

419 It was proposed by Cllr Collins, seconded by Cllr Mrs Atkinson and agreed that the minutes of the meeting held on 10th January 2018 be signed as a true record.

4 MATTERS ARISING.

420 No matters were raised.

As members of the public were present, it was agreed to vary the order of the agenda.

12 DEANGATE RIDGE GOLF COURSE

421 The Chairman suspended the meeting to enable the members of the public to speak.

Cllr Crozer said that the decision to close Deangate Ridge has been taken by Medway Council. Members of our community and parish council believe that how Medway Council has operated is in fact outside of their own policies and procedures. Cllr Crozer invited Joanne Shorter to speak to the meeting regarding what has happened to date. Ms Shorter explained that she and Cllr Crozer have presented Medway with a petition asking them to reconsider the closure of this facility.

A week ago the cabinet made the announcement that they were going to consider the closure of Deangate Ridge. Ms Shorter and Cllr Crozer believed that this consideration had been made without a viable business case. Medway Council had worked the report from a dictatorship point of view rather than a democratic view. An insight into how they would take forward the Medway Plan. The draft plan ignores the industrial areas, the vacant property and Capstone Park. Ms Shorter stated that a full analysis should be taken of Deangate rather than dictating to the public how they would like to move forward. A number of FOI requests had been submitted by the parish council and members of the public – all of the information that has been asked for should be able to be provided if they had completed the business case in the correct way. Cllr Crozer said that Deangate is the first nail in the coffin to the rest of the peninsula. The first consultation will be taking place in March in regards to the local plan. A formal conduct investigation has been opened regarding Medway Cllr Barry Kemp after the email that he sent saying that he hoped that the cleansing at Deangate had been completed.

Jeff Westlake – Golf Fraternity from Deangate Ridge – 25% of Deangate revenue comes from golf club members – 75% of the revenue comes from pay and play – this has not been taken in to account by Medway Council – evidence of the poor business case that they have based their decision on. The club members have in a short time responded and pulled together a large number of signatures for the petition. Jeff has also contacted Golf England who may be able to offer legal support.

David Saunders is a member of the RSPB but was not speaking as a representative. He spoke about the routine maintenance that has taken place at Deangate. He was not am not representing the RSPB nationally – Adrian Thomas the RSPB nominated representative had voiced an opinion about Deangate – this is available for review on Facebook.

The Chairman thanked the members of the public and reconvened the meeting.

It was proposed by Cllr Andrews that High Halstow Parish Council is wholly against the closure of Deangate Ridge Golf course. The motion was seconded by Cllr Mrs Atkinson and carried unanimously.

Cllr Crozer then made a call for volunteers to go through minutes in relation to Deangate – 1968 – 1972, if there had been any discussion regarding Deangate being solely used for leisure this could stand up in court. The next meeting of Medway Council's cabinet was due to take place on 22nd February and it would be advantageous for people to attend.

5 PLANNING

a Applications

- 422 i **MC/18/0096:** Land adjoining 35 Cooling Road: Outline planning application for the demolition of outbuildings and erection of six 3 and 4 bedroom detached and semi-detached dwellings with associated garages, parking, landscaping and improvements to existing vehicular access with all matters reserved except for access

After discussion, it was agreed to object as follows:

High Halstow Parish Council objects to this application. Members consider there would be over intensification of the site. There are also concerns about the infrastructure.

There are problems with the foul water pumping station; the primary school is oversubscribed; medical services are insufficient; the road is narrow and unsuitable for volumes of traffic - 6 family homes could generate 24 cars or more. There would be loss of amenity to neighbouring properties. The land is outside the village envelope and therefore would be development in the open countryside which is contrary to planning policy. Some years ago permission for development on the site was refused and an appeal was dismissed.

The Parish Council draws attention to the objections from neighbours and a former neighbour and to the fact that none of the letters of support come from residents of High Halstow.

Miss Bloomfield had spoken to the clerk to Cliffe and Cliffe Woods Parish Council for advice as they have started their neighbourhood plan already. Chris Fribbins also confirmed that more than one parish can join together but other parishes have demonstrated that this can be complicated. Initially Chris thought that a peninsula plan could be good – but working together with other villages trying to safeguard their own areas could prove to be difficult.

Cllr Collins – Not against it – but worried that a government could overturn it after we have completed that amount of work as has happened in other areas of the country.

Cllr Crozer – High Halstow will have to take some proportion of houses – do we want to have a say or not? He was of the opinion that all of the villages should have a neighbourhood plan – but joint objectives.

Cllr Crozer said that a committee should be formed– a committee should be formed to take the local plan forward.

Cllr Mrs Atkinson proposed that the Council go ahead with the neighbourhood plan. This was seconded by Cllr Crozer and the motion was carried unanimously.

A meeting to be arranged to invite volunteers and council reps to attend a meeting regarding - meeting in the next week. It was agreed the PARISH Council representatives be Cllrs Collins, O’Hanlon and Mrs Atkinson. Miss Bloomfield was asked to research how to start and funding. It was agreed to invite Chris Fribbins to the first meeting.
