Dear Cllr Atkinson

Thank you for your recent email regarding Medway Council's Housing Infrastructure Fund (HIF) and development on the Hoo Peninsula.

Since the consultation was launched on these plans earlier in the year, I have received over 100 emails from residents who are concerned about the impact that the HIF will have on the Hoo Peninsula and the surrounding area. Most of the email correspondence to me has been regarding one of four issues – the construction of the flyover across the A289 in Wainscott, the proposed railway station near Sharnal Street, the pressures on local infrastructure and how the HIF will not address them, and the conduct of the Leader of Medway Council.

I deeply appreciate the strength of feeling on this issue and am now writing to you to set out my position on the HIF as clearly and as in much detail as possible.

When Medway Council first applied to the government's HIF programme in 2017, along with my colleagues Rehman Chishti MP and Tracey Crouch MP, I signed a letter of support at the expression of interest stage of the bid. I must stress that this was at a very early stage when the Council did not have any formal plans and nor did they have a firm indication of the funding that Medway Council would apply for. I knew that the Peninsula was long overdue for funding to help improve the road infrastructure and it would be a dereliction of my responsibility as a Member of Parliament had I not supported the expression of interest as I always want the best for my constituency and for my residents to benefit from Government funding to deliver the much-needed infrastructure and investment we desperately need in Medway.

Since this time, over the course of the past 4 years, I have been raising my concerns with Medway Council regarding the progress of the Local Plan and the HIF. This has been in the form of meetings and correspondence with senior council officials. Since March 2018, I have sent a total of 15 letters to either the Leader of the Council or senior officers of the council pertaining to my ongoing concerns with the Local Plan, the HIF bid, or general development in and around my constituency.

I have not signed subsequent letters of support due to the serious concerns which I have held regarding the delivery of the project. At every opportunity, I have always made my worries clear to the Council about the project and the impact it would have on my constituency.

Despite the countless hours of meetings and reams of correspondence with the Council over the past few years, I have learned very little about the Council's intentions within the Local Plan and the HIF bid. I therefore still share grave concerns about the impact that these projects will have on my constituency and am extremely disappointed that important detail has been withheld from me as the Member of Parliament.

At the end of last year, I also approached the Leader of Medway Council, Cllr Alan Jarrett, with a request to join the HIF Members Advisory Board which oversees the progress of the project. I thought that this would help to

allay my concerns and I would also be able to directly speak up for my constituents on this forum who I know are also desperate to know what is going to happen to their villages and roads. I have asked to join this board twice, but sadly my requests have been declined on both occasions.

I have long held that Medway Council will struggle to deliver all of their plans for the road, rail and environmental improvements with the £170 million which they originally requested from central government. I cannot understate the scale of this project and the impact that it will have on the Medway Towns. It has been worrying to see recently that key parts of the project have already started to fall apart — particularly, the rail scheme which will now not include a Medway link to other local stations, and will therefore not benefit local residents or our own economy.

Moreover, fundamental parts of the Local Plan remain unfinished, including the Strategic Transport Assessment and the environmental assessment, and it is baffling that we are still continuing with a major infrastructure project without having completed key elements of the Local Plan's evidence base first. The HIF project is vital to the successful implementation of the Local Plan, but it would appear that the planning and HIF teams are not working in unison with each other.

I know that I am not alone with my concerns. I would encourage you to view the latest Medway Council Regeneration, Culture, and Environmental Overview and Scrutiny Committee meeting where a number of councillors, from both sides of the political divide, explain their concern as they hold the Head of Regeneration to account.

For the reasons outlined above, I have little confidence that Medway Council can deliver their plans outlined in the HIF to time or to budget and cannot in all good faith support the HIF project in its current state. Please be assured that I will do everything I can to make sure that the voices of my constituents are heard loud and clear by ministers who are keeping a close eye on Medway's progress. I will do all I can to work with and support the number of stakeholder groups on the Peninsula who all share my concerns.

It is a very sad situation that we have the opportunity to invest with infrastructure that could benefit the area, but we are being presented with incomplete proposals, and with many questions or details left unanswered. It's very disappointing that the Council have decided to take this forward without the involvement of the community, locally elected councillors, the Member of Parliament and the residents who will be affected.

I do hope that this has helped to outline my position on the HIF project. I will continue to keep you updated with any important developments, but please do contact me if I can provide any further assistance to you in the meantime.

Thanking Kelly

I have written to Kelly and thanked her for her supportive stance on facebook and in correspondence with other residents. I have also asked for her response to some questions. Even though the consultation period for the HIF bid is over I think its important that we continue to make our voices heard through our elected ward and constituency representatives.

For me there are questions and considerations that are not being asked and properly answered.

<u>Do we need the number and type of houses proposed here in High Halstow, on the Hoo Peninsula and across Medway?</u>

• According to the Office of National Statistics Medway's population is declining and indicates that half the number of houses being proposed are needed. In their recent response to a consultation on the white paper "Planning for the Future" central government accepted the figures that are used for assessing the number of

houses required uses outdated statistics. They decided to keep with those figures in order to "prevent uncertainty"

Many of the houses likely to be built in High Halstow and other areas of the Hoo Peninsula will fall into Band D for council tax purposes i.e. they will provide significant income for the council. Most of the houses built will not meet the needs of those most in need.

• Medway Council claim that they have to comply with central governments housing targets or face "repercussions". In their response to the consultation on the white paper "Planning for the Future" the government state that the numbers suggested to local authorities are not a target but a starting point in determining need alongside other constraints areas face such as green belt and land available for development. It is up to local authorities to determine precisely how many homes to plan for.

Are Medway Council's plans in keeping with the government's pledge to "build the right homes in the right places?"

- The Campaign for the Protection of Rural England suggests that there are enough brown field sites to meet the government's housing targets for the duration of this parliament. Central government state that they have a brownfield first policy. Unfortunately, brownfield sites are less attractive to the large volume house builders as they are more expensive to develop.
- In light of Brexit and the insecurity of our food supply due to climate change should grade 1 agricultural land ever be considered for housing development?

Memorial Hall Re-Opening

It has been decided by the Memorial Hall Committee, alongside Government Guidelines to open up the Memorial Hall for use once more from Monday 21st June. There will be posters to remind all users of Hand, Face, Space. Hand sanitiser placed at entrance and exits of the hall as well as kitchen and toilets. It will be necessary to restrict numbers to a maximum of 20 people per group and there will be no birthday parties allowed for the rest of this year. The committee will do all they can to ensure the safe use of the hall but each group will also have responsibility to ensure the hall is used in a safe and socially distanced way.

Halstow Edge Thriller in National Village Cup!

Cricket is back at Rayner's Meadow. In spite of temperatures more suitable for skiing, the 2021 season got underway on 10th April. COVID restrictions have meant that our winter and preseason training has been severely disrupted so it's not surprising that everyone was rusty. Unsurprisingly, results and performances in our opening friendlies have been patchy at best, but, more importantly, these games gave everyone a chance to blow the cobwebs away ahead of the start of competitive cricket.

That competitive cricket got underway with a home tie against Bidborough CC in the 1st round of the National Village Cup on 25th April. The NVC is a prestigious competition that gives village cricketers the opportunity to play at the home of cricket – Lords. The club has a proud tradition in the competition- having reached the last 8 nationally on 2 occasions – so we were keen to perform well.

Asked to bat on a bowler friendly pitch (typical for April) our

batsmen found scoring runs and building partnerships difficult and we were bowled out for a disappointing 128 in the 36th over. The consensus was that we were 20-30 runs short of a competitive total, but, if we could pick up early wickets, we would be in with a chance. Chris Whatman duly obliged, picking up the first wicket with only 11 on the board but from there Bidborough's batsmen seemed to be taking the game away as score progressed to 46 in good time & without incident. Two wickets in two balls from Clark Dockwray put the brakes on & switched momentum back our way. From there the game ebbed and flowed. For a long time, it was hard to pick a winner until a flurry of wickets meant that Bidborough were 9 down with 25 still needed. In a nail biting finished Bidborough's last pair inched towards the target as our bowlers strove to get the wicket that would see them through to the next round. As the runs required got below 10 it began to look like Bidborough might sneak over the line until stand-in Captain Jamie Maguire

turned to Rob O'Hara to try to get the breakthrough. After 3 good balls Rob bowled a loose delivery. Seeing the opportunity to get within 3 runs of victory Bidborough's captain — who had played a watchful innings until that point — tried to smash the ball through the covers to the boundary, but he only succeeded in hitting the ball straight to Archie Lally who gratefully took the catch that put us into the next round by the slenderest of margins.

The next round of the NVC sees us take on Leeds and Broomfield on 9th May. If we are still in the competition by the time the next edition of the High Halstow Times comes out, we will be

preparing for the County final so wish us luck.
